- ELECTRICITY WILL NOT BE SUPPLIED. YOU MUST BRING YOUR OWN GENERATOR IF POWER IS NEEDED.
- FOOD VENDORS MUST PROVIDE INSURANCE NAMING THE PORT OF LOS ANGELES AND LOS ANGELES MARITIME INSTITUTE AS ADDITIONALLY INSURED
